Improper Use of Coupons Has Resulted in Terminations

Technology makes it very easy for companies to track which transactions generate coupons. Unless you have received a coupon during a transaction in which you were the paying customer, **DO NOT USE IT**.



Using a coupon that you found or was given to you by a customer is considered theft and may result in termination, regardless of your seniority or work record.

Several members have been fired for improperly using coupons, including a member who was given a pharmacy coupon by a friend to help with her medical bills. Protect your job; do not misuse coupons.

Open Enrollment for 2016 UFCW Health and Welfare Fund Benefits Begins November 17
