UFCW 951 FOUNDATION COLLEGE SCHOLARSHIP DEADLINE IS MARCH 31: \$30,000 TO BE AWARDED



For over a decade, the UFCW 951 Foundation has been helping ease the cost of attending college for UFCW 951 members and their families. The UFCW 951 Foundation will be awarding fifteen \$2,000 scholarships in 2019. Scholarships will be awarded to eligible members, their spouse, children or their grandchildren (under the age of 25) attending a college, university, community college or recognized trade school.

MEIJER MEMBERS MUST COMPLETE HEALTH SCREENING BY MARCH 31

The deadline for members at Meijer to complete their health screening for the Healthy at Meijer program is Sunday, March 31. Members can complete their health screenings by following the instructions on the Jiff app or website at app.jiff.com, and then scheduling an appointment with their primary care physician to have the form completed prior to the deadline. Members may also visit any Meijer pharmacy for a screening.

The benefits of completing the screening and participating in the program include discounts on health insurance premiums, increased company contributions, and access to new programs, tools and resources to help improve and maintain health.

Insurance costs shown on the Meijer Rewards site already reflect the discounted premiums. Members at Meijer who do not complete the health screening by the March 31 deadline will be charged a higher insurance premium than is listed on the website.
