

If one or more of your dependent children, or non-dependent grandchildren, are involved in an extracurricular or community program that supplements their core education, the UFCW 951 Foundation Family Enrichment Reimbursement can help with associated costs. Eligible programs include, but are not limited to, sports, scouting, music and arts, dance class, school clubs, lessons, tutoring, etc., for children in kindergarten through 12th grade. Post secondary expenses, such as college, are not eligible for this award.

\$2,000 in Family Enrichment Reimbursements will be awarded in 2024. Five scholarship winners will be selected in each of the following months: January, April, July and October. Reimbursements will be awarded for participation costs paid in 2024.

Any costs directly related to your dependent child(ren)'s or grandchild(ren)'s participation in an extracurricular, community or supplemental program are eligible for reimbursement.

MEMBERSHIP MATTERS

Eligibility Requirements

- UFCW 951 member in good standing for at least 90 days prior to being awarded a reimbursement. Winners must be a member in good standing to receive reimbursement monies.
- Dependent child(ren), or non-dependent grandchild(ren), of UFCW 951 members must be enrolled in an extracurricular or community program that supplements the child's core education. The eligibility of a program will be determined at the discretion of the selection committee.
- Post secondary expenses, such as college, are not eligible. Apply for the UFCW 951 Foundation College Scholarship or Education Reimbursement instead to cover higher education costs.
- Provide proof of fees paid for an eligible program in 2024.

Annual Awards

- Twenty Family Enrichment Reimbursement Awards of \$100 each will be awarded in 2024, with five reimbursement winners selected in each of the following months: January, April, July and October.
- Reimbursements will be dispersed for expenses incurred by child(ren)'s participation in a supplemental, extracurricular or community program.
- Reimbursement winners will be selected by a committee of representatives from the UFCW 951 Foundation and UFCW 951. UFCW 951 members may only win a Family Enrichment Reimbursement once per calendar year.
- Quotes from winning essays and member photos may be used in future publications.

2024 Family Enrichment Reimbursement Application

The decision of the selection committee is final. Winners only will be notified by UFCW 951. Reimbursements will be dispersed for expenses incurred by child(ren)'s or grandchild(ren)'s participation in an extracurricular, community or supplemental program.
