## ELIGIBILITY REQUIREMENTS

- Be a UFCW 951 member in good standing for at least 90 days prior to being awarded a reimbursement. Winners must be a member in good standing to collect their reimbursement.
- Provide proof of utility bills paid in 2024, specifically electricity, water, natural gas or propane. Other utility bills, including internet, telephone and trash, are not eligible for this award.



## ANNUAL AWARDS

- Eighty Utility Awards of \$150 each will be distributed in 2024, with 20 winners selected in each of the following months: January, April, July and October.
- Awards will be dispersed as reimbursements for utility bills paid in 2024. UFCW 951 is not responsible for paying any utility provider directly. Eligible utility bills must have been billed to the member's address on file with UFCW 951. If your address has changed, please update the UFCW 951 office at 1.800.999.0951.
- Award winners will be selected by a committee composed of representatives from the UFCW 951 Foundation and UFCW 951. UFCW 951 members may only win a Utility Award once per calendar year.
- Quotes from winning essays and member photos may be used in future publications.
